On 02nd December, 2025, the President of the United Republic of Tanzania, Her Excellency Dr. Samia Suluhu Hassan held talks with The Rt. Hon. Lord Hugo Swire KCMG, the Deputy Chairman, Commonwealth Enterprise and Investment Council (CWEIC), at the Dar es Salaam State House.

Their discussions focused on strengthening trade ties and unlocking new investment opportunities that support national economic growth and job creation for Tanzanians.
